Dear Parents/Guardians

As you are aware, the National Assessment Program – Literacy and Numeracy (NAPLAN) for Years 7 and 9 students is held in May each year. NAPLAN tests assess student knowledge and skills in Writing, Reading, Conventions of Language (spelling, grammar and punctuation) and Numeracy. The results of the tests provide information for students, parents, teachers and principals and can be used to improve student achievement.

In 2018, NAPLAN began transitioning from a paper based test to an online assessment (i.e., students complete the tests utilising a computer or tablet). NAPLAN Online delivers numerous benefits including:

- a 'tailored test' design that adapts to correct and incorrect student responses providing a more precise understanding of student achievement;
- innovative use of technology, including a more engaging test design and a wider range of item types;
- the extension of the 'test window' to two weeks, allowing schools greater opportunity to schedule the tests at times that suit them best and increasing student participation.

Our school is again conducting NAPLAN Online in 2020. This means that from **12 – 18 May 2020**, students at our school will undertake all NAPLAN tests online in place of the paper tests.

Due to the online nature of testing during 2020, tests will be conducted in class rather than year groups. Tests will therefore be spread over a longer testing window and will occur throughout the day as necessary. For this reason please try to limit absences during the testing period of 12 - 18 May.

All students are expected to participate in the NAPLAN Online tests. Catch up testing will be conducted for individual students who are absent on test days on Tuesday 19th May.

Support can be arranged for students with disabilities, if the student regularly uses similar support for classroom assessment tasks.

Exemptions may be granted to students with significant intellectual disabilities and to students who have been learning English for less than one year. If your child is eligible for support due to disability or exemption, you should discuss this with the Learning Enrichment Coordinator, Denise Slattery, prior to the tests. Parental consent is required before any support due to disability or exemption is granted.

Students may be withdrawn from NAPLAN by their parent or carer. This is a matter for consideration by parents and carers in consultation with the school. If, after consultation, you decide to withdraw your child, you must sign a Student Withdrawal form. These forms are available for printing by the school. Please contact Mr Jim Kelliher, Director of Learning and Teaching if you wish to discuss the withdrawal of your child and arrange the printing of a withdrawal form.

To familiarise students with the online testing process, familiarisation sessions will be conducted from the 23rd of March.

Later in the year you will receive your child's personal NAPLAN report. The report will describe your child's particular skills in Reading, Writing, Conventions of Language (spelling, grammar and punctuation) and Numeracy. The report will also show how your child performed in relation to national minimum standards. These describe the minimum acceptable standards for students across Australia.

I am confident that the information you receive as a result of your child's participation in the NAPLAN tests will be valuable in helping you to assess your child's progress in literacy and numeracy.
